REGISTRATION AND VOTING INFORMATION

TO BE ELIGIBLE TO VOTE you must be a citizen of the United States; at least 18 years of age by Election Day; a resident of Westchester County for 30 days prior to the election; and registered. If you have moved since the last time you voted, you must re-register. (See “Registration”.) You may also go to www.lwvs.org.

GENERAL ELECTIONS are held on the first Tuesday following the first Monday in November. The general election will be November 5, 2019. If you are registered with the Westchester County Board of Elections, you are automatically eligible to vote in all general, village and school elections.

The primary election will be June 25, 2019. In order to vote in a **Primary Election**, you must be registered with the party holding the election.

Absentee ballots may be obtained in person or by telephone from the Westchester County Board of Elections or online at citizenparticipation.westchestergov.com/voting/absentee-ballots. An absentee ballot must be postmarked by the day preceding the election and received up to 7 days after by the Board of Elections or delivered in person to the Board of Elections on Election Day in order to be counted.

The **handicapped or physically challenged** may vote even if unable to sign. Contact the Board of Elections for instructions at www.elections.ny.gov.

LOCAL ELECTIONS

Village Nonpartisan Nominating Committee Elections: As part of Scarsdale’s non-partisan system, eligible residents vote for representatives to the Citizens Nominating Committee (CNC) and the School Board Nominating Committee (SBNC), each committee charged with nominating individuals for vacant positions on the committee. The CNC election will be in November 2019. The SBNC election will be in January 2020. Calendars, mail-in ballots and voting instructions can be found on their respective websites www.scarsdaleprocedurecommittee.org and www.scarsdalesbnc.com.

Village elections are held on the third Tuesday in March. If you are not registered to vote in the general election, you are not eligible to vote in the Village elections. Applications for absentee ballots may be obtained at Village Hall or online at www.scarsdale.com

School Board elections are held on the third Tuesday in May. If you are not registered to vote in the general election, you may vote in the School Board elections by registering at the Scarsdale Board of Education office located at Scarsdale High School, Brewster Road. Absentee ballot applications may be obtained from the District Clerk at the Board of Education office or by calling 721-2410.

REGISTRATION You may register **in person** at the Board of Elections or at the Department of Motor Vehicles in White Plains when you apply for or renew a driver’s license or ID card, Mondays through Fridays.

You may also **register by mail**. Mail applications are always available at Scarsdale Village Hall, the Scarsdale Public Library and the Scarsdale Post Office. All applications must be received by the Westchester County Board of Elections at least 25 days prior to the election.

If you change your name or address, you must notify the Board of Elections using a voter registration form. These changes must be received no later than 25 days before a special, primary or general election. To change your party enrollment or enroll for the first time in a party, you must also use a Voter Registration form. All changes of party enrollment go into effect **once a year**. They must be filed 25 days prior to the general election and **will go into effect seven days after the general election of that year**.
